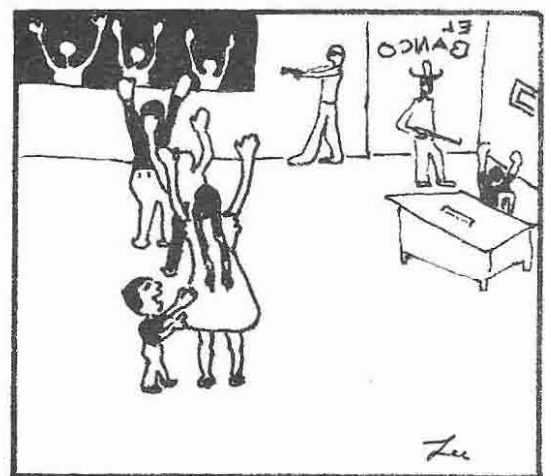
CLOSE CALL
