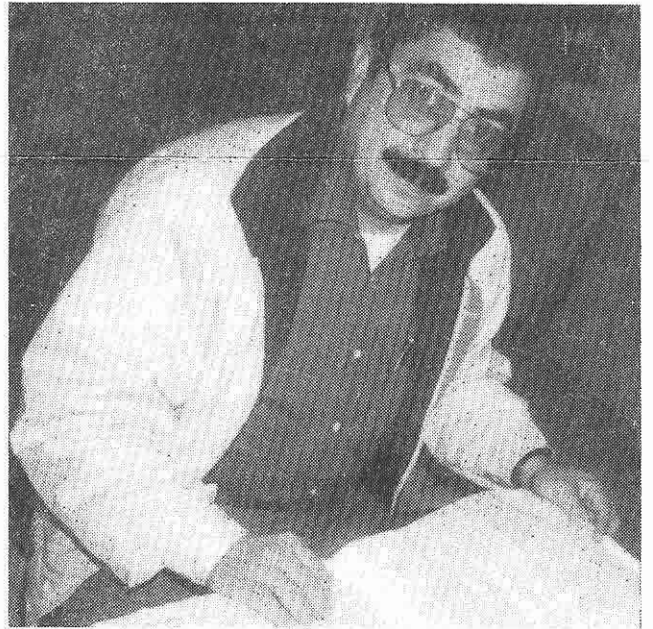
Dear Friends,

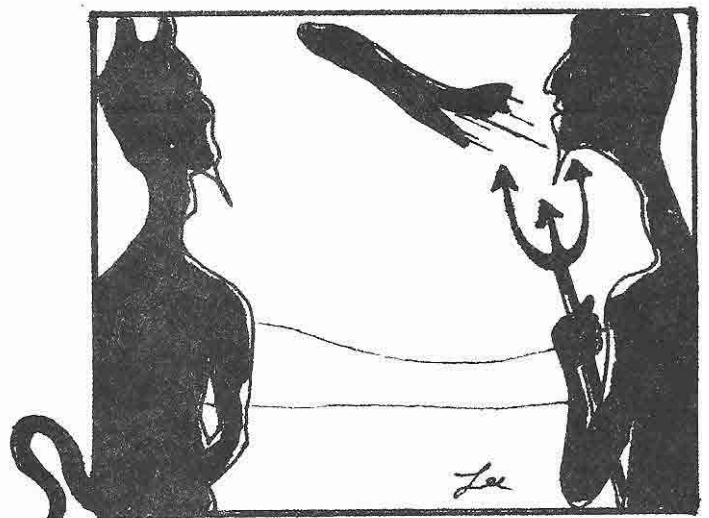
