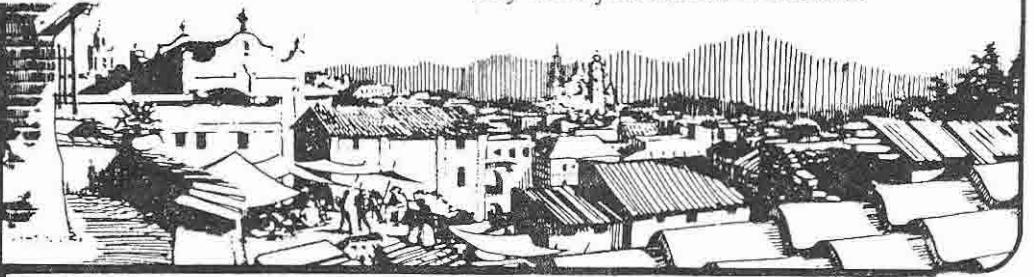
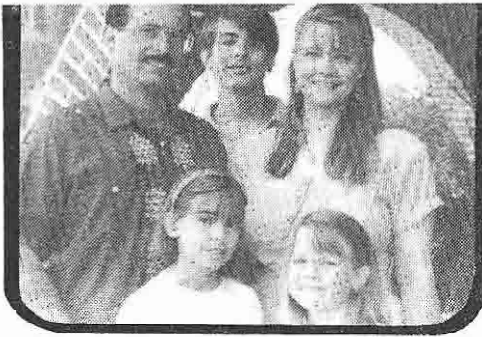

Dear Friends,

On May 24th I picked Carol up at the Guadalajara airport after a month in Birmingham seeing her doctor to adjust her thyroid medication and speaking at various churches. We stopped in Chapala, checked the mail and about an hour later, arrived home to hear the news! The Cardinal of Guadalajara was assassinated at the GUADALAJARA AIRPORT only hours after we had left!! Seven people died that day, cut to ribbons by the machine gun fire.

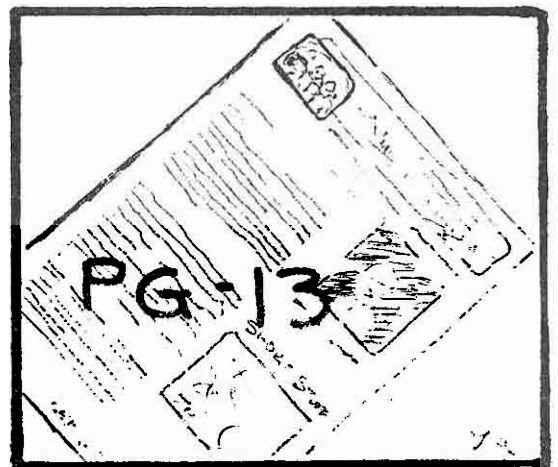
There are all kinds of rumors and theories of why this took place. The News Media and the Government declare it was the work of drug traffickers, and that the Cardinal was an innocent bystander, others say that he was targeted by the drug cartel, for speaking out against them. (The press writes what the government permits). There are rumors that this was the work of the Mexican Government, because the Cardinal was outspoken on behalf of the victims of the explosion in Guadalajara, chiding the government to make good on it's promises and take responsibility for the destruction, sometimes leading demonstrations and unrest.

Still another theory from a person I highly respect was that it was a political move from within the Catholic Church. The only other Cardinal in Mexico was close to retirement, and there was much positioning within the church to determine who would ultimately hold control. The real motive of the assassination may never come to light, but we were touched with the grief and

sense of loss as we saw the hurt and confusion of this nation. We also give thanks that Carol did not take the later flight which would have thrown us in the middle of this act of senseless violence.
